Logistical information

The organizing committee of DAVOS NORDIC is pleased to invite once again top athletes to a cross-country skiing world cup in Davos. Due to the current situation some adjustments and changes are necessary and we would like to ask you to read the following documents and the information below carefully:

Accreditation

All teams and staff have to use the FIS online registration system. On site one person of each team will pick up the personal accreditations for each team member at the race office in the stadion. They have to be carried on person all the time. Accreditation will only be possible to pick-up after the negative Covid-19 test (not older than 72 hours) of each team member is uploaded on the new FIS Passport system.

The tests have to be uploaded 10 hours before accreditation .

The accreditation office is located in the race office in the stadion. Only 1 person per team is allowed to pick up the accreditations for the whole team.

Contact Tracing

In order to ensure contact tracing, all entries into a zone (stadion, training track) or into a room (athlete tent) are registered by the OC. For this we use the app Mindful.

Please download the app to your cell phone in advance. The entry and exit of a zone can then be registered via QR code. Without registration no access is possible.

Testing Protocol

All members of the red group (teams, officials, SRS, etc.) must have a negative Covid-19 PCR test to be accredited. The test must not be older than 72 hours and must be uploaded to the FIS Passport Tool.

Test Center Davos

Teams that do not have the opportunity to do their test before departure can have their test on site. The tests must be registered in advance using the following form:

Tests will be paid directly on site or charged to travel expenses. Costs: CHF 130.00 / test including handling fee. The same process applies to tests after the event, some of which are required for further travel.



Accommodation

- Booking according to the FIS Rules via FIS Online registration system
- The OC offers the following accommodation (full board included): CHF 125.00 (different categories)
- Price for additional accommodation outside of the quota: on request
- Price for additional single rooms outside of the quota: on request

Team Catering

Due to Covid-19 restrictions and preventions, all athletes and team members will eat all meals in the hotels. For those who will need to stay in the venues for a longer time, please coordinate with your team hotel directly to pack lunch bags instead of the full board menu in the hotel. There will be the possibility to get something warm to drink at the waxing area as well as in the team area in the stadion.

Transportation

Official airport: Zürich

The organizing committee will arrange transportation between the airport and the hotels. 1 transport (from and to the airport in Zürich) is free of charge for each team. If you want to travel from Munich or to Dresden we will charge you only the difference between the two locations.

Transportation within the destination (hotels – venue): walking distance or public bus (free of charge with guest card) Please be aware that due to COVID-19 it is mandatory to wear a mask in the waiting zone, airports, railway stations in public transport as well as in the OC-organised airport shuttles!

Travelling to Switzerland

Rules and regulations in Switzerland



The Swiss Federal Council resolved measures to curb the further spread of the coronavirus. Given the growing number of new infections it will be compulsory to wear a mask in all publicly accessible indoor spaces and at all public transport access points across Switzerland; this includes, for example, restaurants, shops and theatres and railway stations, airports, bus and tram stops. Already since 6 July 2020 a mask-wearing requirement has applied to all public transport.

Quarantine Regulations

If you are staying less than 5 days

Persons who are entering Switzerland from one of the above mentioned countries for up to 5 days for professional reasons and who cannot be postponed, are excluded. In justified cases, the competent cantonal authority may grant further exceptions from the obligation to quarantine or grant facilities.

If you are staying for more than 5 days

If your team is staying in Graubünden for more than 5 days and your country is on the quarantine list, please contact the cantonal authority for an exemption. Please send your request with the corresponding reasons at least 14 days prior to your arrival to the following e-mail address: kfsinfo@amz.gr.ch

VISA for third countries

For third countries a visa is required for entry. Even though no visas are issued at the moment due to the Covid situation, there is a solution for professionals and professional athletes. Please contact the Swiss embassy in your country.

To obtain a visa, the Swiss representation in the respective country must be contacted. They are authorized to issue a permit. If you receive a negative decision against all expectations, please contact us with your request, so we can help you.

Reimbursement

- Accommodation costs: Teams will pay directly in their hotels.
- Carrying costs/Reimbursement: Expense sheets will be received in the race office during the race weekend or by e-mail: Payments will be done by bank transfer.
- Please make sure you leave your bank details at the financial office or you send it to davosnordic@davos.ch.

Prize money

- Due to data protection rules the data's from the athletes have to be given directly to: davosnordic@davos.ch
- The prize money from is available on FIS Website
- Athletes from Switzerland and Liechtenstein are excluded from the income tax. By all other nation we have to subtract the income tax from the by bank transferred prize money. The income tax is the following:
 - Income tax for prize money until CHF 200.- 12.8 %
 - Income tax for prize money from CHF 201 to 1'000.- 14.4 %
 - Income tax for prize money from CHF 1'001 to 3'000.- 17.0 %
 - Income tax for prize money higher than CHF 3'001.- 19.0 %
- The prize money payments will be done by bank transfer.



- Please make sure you send the completed prize money form within a few days after the event to the OC!

Waxing facilities

- Wax cabins are available from Monday, 7th of December, 13:00 until Sunday, 13th of December, 17:00
- Waxing trucks: teams arriving with trucks have to inform the OC before 15th of October 2020
- The keys to the cabins are available at the Stilli. The deposit is 50.00 € or CHF per team. Keys return to the desk at Stilli area on the day of departure.

Special permissions for truck driving

(Sunday and night, other days with special regulations)

- Attention: In case of heavy snowfall the Flüela and Wolfgang pass might be closed, please inform you before you drive. If you drive on Sunday or at night with your trucks you need a permission in Switzerland, Tirol and as well in South Tirol. We please ask the trucks to stay until Monday or making sure that you get all the permissions.

Regulations of radio equipment / radio frequencies

Since 2013 the legislator has restricted the usable frequency range for certain wireless devices multiple times and exempted from the license-obligation. This increases the risk of interference between wireless devices at large events. In order to guarantee the same level of production reliability in the future and enable everyone to enjoy interference-free operation, SRF will coordinate the frequencies on behalf of the event organiser at Davos Nordic 2020.

For the above-mentioned reasons, all users must register their wireless devices in advance via webtool FreqCoord. Wireless devices may not be used if they have not been registered.

Mandatory registration

- From 8 - 13 December 2020
- In the following areas: The racetrack, finish area and everywhere you need access authorisation (accreditation) from the event organiser.

The following devices must be registered:

- Wireless microphones
- In-ear monitor systems
- Wireless intercoms
- Walkie talkies (PMR)*
- Telemetry systems*
- Wireless cameras*
